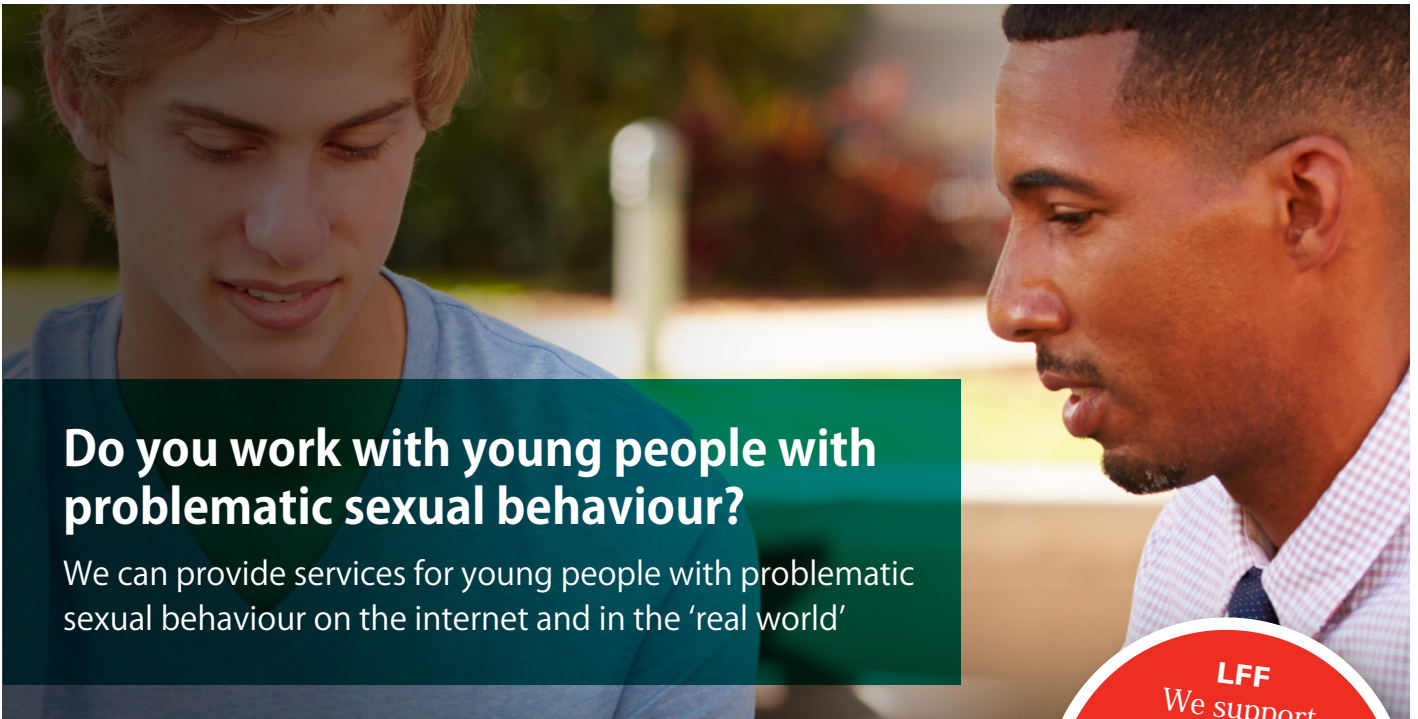

Do you work with young people with problematic sexual behaviour?

We can provide services for young people with problematic sexual behaviour on the internet and in the 'real world'

We support professionals, parents, carers and young people with concerns about problematic sexual behaviour

The Lucy Faithfull Foundation works with children and young people who have displayed problematic sexual behaviour on the internet or in the 'real world', to prevent an escalation or recurrence of the behaviour. We also work with their families or their main care giver.

We can offer one to five sessions of work with the young person and their family, tailored to their needs. Each session will be delivered by an experienced practitioner either by telephone (through our Helpline) or face-to-face.

The sessions are educative, designed primarily to provide support, advice and information to young people and their families. In the event that the young person requires more in-depth intervention and/or safeguarding procedures need to be implemented, this will be discussed with the referring agency. The Foundation can provide additional assessment and intervention services provided funding is available.

We can help with:-

Problems with online behaviour

Problematic online behaviours could include:

- Arrests for Internet related offences including those related to sexually explicit images of children / accessing illegal images of children
- Risk taking online behaviour
- Young people accessing adult pornography
- 'Sexting' (the sharing of sexually explicit images taken of themselves or of others)
- Concerns in school about a young person's online behaviour

Problems in the 'real world'

'Real world' problematic sexual behaviours that we seek to help young people and their families recognise, understand and respond to are those which:

- Are rare for the developmental stage and culture
- Are frequent
- Are a preoccupation
- Fail to respond to normal correction from adults or continue to occur unabated after normal corrective efforts
- Involve significant age and developmental differences between the children involved
- Involve any use of force, intimidation or coercion and/or the presence of any emotional distress in the child or children involved
- Cause physical injury

What does the Lucy Faithfull Foundation do?

Our specialist trained staff will:

- Meet with the young person and their parents or carers (separately or together), explore what has happened, the needs of the family and young person, and how we can help
- Support young people and their families in finding the answers to questions about the concerning behaviour, and help families start communicating about these matters
- Educate young people and their parents/carers about internet safety, and how to keep safe when using new technologies

Where the young person is estranged from their family or is a 'looked after' child, the most significant adult in the young person's life will be invited to be involved. The programme will be flexible to the individual needs of the young person.

How we work with referring agencies

The Foundation will request a single point of contact within the referring Police Service or other agency.

This will facilitate contact in the event of any safeguarding issues arising, enable feedback to be provided on the referral and enable the referrer to contribute to the Foundation's evaluation of this service.

Any work with the young person and his/her family will be conducted in-line with the Foundation's protocols relating to confidentiality, safeguarding, further offence disclosure etc. The referring agency and the family/young person concerned will be given information about these protocols from the outset.

What will the service cost?

The Foundation is able to provide this service free if certain criteria are met. Please call us to discuss.
